Notes / Narratives

On 07-20-2013 I was working in my capacity as a Scottsdale Police Officer with a regulation blue uniform and a fully marked police vehicle. I was also wearing an On Body Camera (OBC).

At approximately 0315 hours I was dispatched to 5904 N Granite Reef Rd reference a family fight. The notes to the call indicated that the female RP had just been in a physical fight with her boyfriend. She stated that he would not leave and that he had smashed her head into the wall. She also stated that he was a professional fighter trained in wrestling. She declined fire and stated that she just wanted him off the property.

I arrived on scene and spoke with the female. She verbally identified herself as OF/MEGAN WELTER. WELTER's eyes were watery and bloodshot and she smelled of the odor commonly associated with intoxicating beverages. Due to WELTER's level of intoxication and being upset it was difficult to interview her. She had difficulty describing the events in chronological order.

Before I started to ask her questions regarding the incident, Sgt Pearson #879 advised her that there were multiple videos of the incident on the male's phone and he wanted her to be honest about what happened. Welter stated "I will admit, I did hit him, I did punch him" She stated that she wanted him to leave the property. The male would not leave and stated that he could not drive.

WELTER then advised that before the male started that he had picked her up and threw her out on the patio. She then stated that he locked the door. She stated that a moment later he opened the door and called her trash. She then stated that she started to yell "Rape" and "Help" because she did not know what to do. She then stated that she went inside and the male pushed her down on to the tile floor causing her to hit her head. She stated at some point he started to choke her. I asked her if she had lost consciousness at any point and she stated no but that she got dizzy.

WELTER then went back and explained that they had gone out drinking for her birthday. After they returned to the house she stated that she fell asleep on the couch. She stated that she woke up and the conflict started because the male had gone through her personal phone.

I then looked to see if WELTER had any signs of injury. I could find no marks, bumps, or redness. I also looked to see if WELTER had any signs of strangulation that would be consistent with being choked and did not find any.

I spoke with Officer Berumen #1395 regarding his interview with the boyfriend, V[REDACTED] Please see his supp for further. It was determined that there was PC to arrest WELTER for ARS 13-1203A1 Assault DV, ARS 13-1602A1 Criminal Damage DV, and ARS 13-2904A1 DV.

[REDACTED] stated that he did not wish to press charges.

I took possession of [REDACTED]'s iPhone (serial #DNQKL48QF8H2) which contained the videos. Due to the fact that [REDACTED] did not wish to press charges but had consented to showing us the videos from the phone I attempted to email the video to my Scottsdale account to preserve evidence in case a later forensic exam was unsuccessful. I also allowed [REDACTED] to get his address off the phone to provide to Officer Berumen. I informed [REDACTED] that I would be taking his phone for



On 07-20-13 at approximately 0315 hours, I was working as a Patrol Sergeant in a fully marked police vehicle in full regulation uniform. I responded to a family fight at 5904 N Granite Reef Rd.

Upon arrival I asked the Dispatcher to have the female step outside to the rear of the residence. I was equipped with an On Body Camera (OBC) and recorded my involvement in this matter.

A W/F came outside who was on the phone with the 911 Dispatcher. She stated that her boyfriend was inside of the house in the living room area and that she wanted him out.

A W/M then came to the back patio of the residence and I had him have a seat on the ground while I waited for other officers to arrive on scene. I asked the W/M what had happened and he stated that his girlfriend of 6 months who he is currently living with got upset over a text message.

He stated that he had sent a girl a reply from a text message she had sent about a dog. He stated his girlfriend was extremely upset about it and began to hit him and pull his hair.

The W/M stated that he recorded on his cell phone part of the assault from his girlfriend. I began to watch a portion of the video he had recorded on his cell phone. I could hear loud screaming from a female voice. I could also see the W/F who had exited earlier yelling at him and grabbing at his arms.

I had Ofc. Berumen continue the interview with the W/M. See Ofc. Berumen's supplement for further details.

This ended my involvement in this matter.

On 7/20/2013 at approximately 0315 hours FTO Wright #1325 and I were working routine patrol in regulation uniform while driving a fully marked police vehicle in the City of Scottsdale. On the listed date and time I was dispatched to 5904 N Granite Reef Rd reference a call for service for a disturbance. Comments to the call stated that the Reporting Party just got into a physical fight with her boyfriend. Comments further stated that her boyfriend smashed her head into the wall and was a professional fighter. The RP has declined fire and wanted the boyfriend off her property.

Officer Loveless #1345 and I arrived on scene. I observed a female subject, later identified as Megan Welter, standing outside of the residence at 5904 N Granite Reef Rd. Officer Loveless contacted the female subject. See his supplement for further. I made contact with Sgt Pearson # 879 who was with a male subject, later identified verbally as [REDACTED]. Sgt Pearson turned the interview with [REDACTED] over to me. See his supplement for further. [REDACTED] was sitting outside in the back patio of the residence. There were several articles of clothing scattered around [REDACTED]. I observed what appeared to be a scratch on [REDACTED]'s right triceps area. He bloodshot/watery eyes and had an odor of an intoxicating beverage emanating from his person.

[REDACTED] stated the following about the incident between him and Welter:

He and Welter have been dating for approximately six months and were in a sexually romantic relationship. He stated that about a month ago Welter informed him that she was pregnant. She decided to get an abortion against his wishes. On 7/19/2013 they went out to celebrate Welter's birthday at Whiskey Row, a bar in Scottsdale. While at the bar Welter accused him of resenting her. He thought it may have been because of the abortion. He stated that they both drank "a lot" at the bar but could not specify how much. Nothing further occurred while at the bar.

When they arrived at the residence Welter went upstairs to sleep. She awoke at approximately 0315 hours and an argument ensued between him and Welter over past relationships. Welter was upset that a girl texted him about a dog. He told Welter that she still talks to her ex boyfriends and asked her to let him look at her Facebook. Welter handed him her phone. He grabbed the phone and stated that he didn't want to look at her Facebook he wanted to see her text messages. Welter yelled, "Why are you doing this" then grabbed her phone and threw it at him. Welter began hitting, scratching and pulling on his hair. He grabbed his cell phone and began recording the incident. He stated that he never hit, pushed or assaulted Welter in anyway. Welter grabbed all of his belongings and threw it out onto the back patio.

I watched the video of the incident on [REDACTED]'s cell phone. It was consistent with his story. I observed Welter yelling at him, scratching him and pulling on his hair while [REDACTED] attempted to calm her down.

I walked into the residence with [REDACTED] so that he could get something to drink. The kitchen was located immediately upon entering into the residence from the backdoor. He informed me that the incident occurred in the kitchen area and the living room area. I inspected the residence to look for any signs or damage that would be consistent with a fight. I observed none. In the middle of the kitchen was a table. On the table were cut up pieces of what appeared to be an ID and credit card. I asked [REDACTED] if the ID and credit card belonged to him. [REDACTED] looked at the pieces and stated yes. He looked at me angrily and

asked, "Now what am I gonna do".

I contacted Welter and asked her if she cut the ID and credit card. She said, "Yes I did". She stated that it occurred during the fight. She asked [REDACTED] to leave her house but he stated that he couldn't because he was unable to drive. He began holding her back and fighting her. He then released her and went into the living room. Welter then grabbed [REDACTED]'s "stuff" and threw everything out into the back patio. [REDACTED] grabbed his "stuff" and brought it back into the residence. Out of anger she cut his ID and credit card. She said, "I fully admit to it and I know I shouldn't have."

I asked Welter why she did not call the police right away. She said she did not feel threatened until [REDACTED] began choking her. She said that he squeezed "tight". She did not feel that he would squeeze to the point that she would die but she did get dizzy. She grabbed her work phone and ran upstairs to lock herself inside the bathroom and call the police. I observed no signs of injuries on Welter. She did not have any signs of strangulation that would be consistent with being choked. She had bloodshot/watery eyes and had an odor of an intoxicating beverage emanating from her person.

I spoke with Officer Loveless regarding his interview with Welter. See his supplement for further. It was determined that there was PC to arrest Welter for ARS 13-1203A1 Assault DV, ARS 13-1602A1 Criminal Damage DV, and ARS 13-2904A1 DV.

Officer Loveless placed Megan Welter under arrest at approximately 0431 hours. See his supplement for further.

The residence and injuries to [REDACTED] and Welter were processed at 5904 N Granite Reef Rd by CSS Officer Cranswick #B1442. See her supplement for further.

I gave [REDACTED] his Victim's Rights Pamphlet.

This concludes my involvement.
